NOTE :

Qualified Residents (QR) are classified as the following:

1. Persons who hold Permanent Residency.
2. Persons legally resident and physically present in the Cayman Islands for at least ten consecutive years immediately prior to enrolment.
3. Persons who are the spouse of a Caymanian or Status holder.

Documents required for #3:

- Marriage Certificate
- Husband's & Wife's Birth Certificates
- Husband's & Wife's Passports

All students will be required to present proof of their eligibility for fee assessment at the time of registration.
